I will be happy to supervise dissertations of candidates graduated in philosophy, management and economics. If you plan to write a thesis in philosophy, your interest in the analytic/pragmatic tradition or methodology is a must. If you want to prepare a dissertation at the intersection of management, organizations, economics and philosophy, a degree in management or economics will be a significant advantage.

Prospective candidates should have a record of conference/workshop presentations and at least one paper in a significant periodical (publications in English will be a plus). I give priority to candidates whose research record fits the proposed research themes.

If you want to write a doctoral thesis under my supervision, feel free to send me via email:

- brief description of your research proposal (2-5 pages),
- brief motivation letter.
- CV with contact details,
- your best publication.

After I read your documents, we will make an appointment. If you decide to have me as your advisor and your application is successful, you will be sure to have a competent and friendly advisor at every stage of your work on the PhD thesis at the Department of Philosophy, AMU (for more info about our doctoral studies look at: http://filozofia.amu.edu.pl/studia-doktoranckie/).
